DDOT – Proposal – Summer 2019 Bus Lanes Pilot

Spring Worth

Pilot H and I Street NW

Temporary bus lanes would operate in the right curb lane of both streets during the AM and PM peak periods

When: June 2nd through September

Why: Buses on H and I have been traveling slower than 3MPH, putting in bus lanes to increase bus speeds and assist with reliability
