### <u>Minutes</u>

### Call to Order

- Commissioner Kevin Wilsey, Vice Chariman, called the meeting to order at 6:38 PM
- Commissioner Tinpe was running late and DDOT had requested to make their presentation early. Since it was a non-voting item DDOT was permitted to give the presentation prior to the establishment of a quorum.

## District Department of Transportation

 A presentation was made regarding the pilot adjustable rate parking meter project in 2C. Donise Jackson from DDOT (donise.jacson2dc.gov 202-478-1450) gave an overview of the project and explained that this is the 6<sup>th</sup> rate adjustment and that the project is going well. Revenues are up and along with that there are more spaces available. A question from the audience centered around where all the parking revenue went to. DDOT says that all the revenues go to WMATA.

#### <u>Quorum</u>

• Commissioners John Tinpe and Kevin Wilsey were present. A quorum was confirmed of 2 of 3 Commissioners.

### Treasurer's Report and Business Items

- Commissioner Wilsey, Treasurer and Vice Chairman, announced that the ANC 2C checking balance was \$44,530.72 at the beginning of September and \$45,649.57. at the end of September. There were no questions about the budget. Commissioner Tinpe made motion to approve the Treasurer's report. The motion was approved. A motion was also made to approve the 2019 budget. The motion was approved.
- Rules of the commission were presented by Commissioner Wilsey, outlining speaking times and question and answer protocols.

   (James.Ceracia@dc.gov) gave a brief announcement about the Mayor's activities. They are seeking a Director for the Office of Night life and hope to make an announcement soon. She established this office on October 1, 2018.
- DC College Savings Plan. Dave Rydzeski gave a brief overview of the DC College savings plan. Tax deferred savings and a tax deduction of up to \$8,000 for contributions to an account set up to fund anyone for educational needs. The money must be used for college expenses to qualify.
