NCPC will hear both sides. Previously, neither Monumental Sports nor its predecessor sought approval of changes to the originally approved signage, so NCPC has only reviewed the original signage. It did not review the current signage before it was installed. They are now looking for options to reviewing it for its impact on historic elements in the surrounding area. No environmental impact study, (106 review) was made. It appeared that DDOT and DCRA did not follow the regulation. In addition this ANC was not informed properly. There is no precedence for this. All entities are involved in this issue: the DC Council, Office of Planning, DDOT, DCRA and the Office of the Mayor.
